### **NEWS RELEASE: ADDITIONAL ARREST STEMMING FROM ORGANIZED RETAIL THEFT CASE IN WALNUT CREEK**

*Continuing investigation results in 4<sup>th</sup> suspect taken into custody*

Arrested: Jordan San Felipe, 21, Antioch

Charges: 211 PC Robbery, 459 PC Burglary, 490.4 PC Organized Retail Theft, 496(a) PC Possession of stolen property.

Additional charges have been filed against another suspect in the November 20, 2021 organized retail theft at the Broadway Plaza Nordstrom. Walnut Creek Police Investigators followed leads and authored an arrest warrant for 21-year-old Jordan San Felipe. San Felipe was arrested on December 14, 2021 and booked into the Martinez Detention Facility. The District Attorney's office reviewed the case and charged San Felipe with four felony counts including robbery, burglary, possession of stolen property and organized retail theft.

Charge: 211 PC Robbery, 459 PC Burglary, 182 PC Conspiracy, 496 PC Possession of stolen property, 29800(a)(1) PC Illegal possession of firearm by felon, 25400 PC carrying a concealed weapon.

Three people are under arrest today following an organized theft at the Broadway Plaza Nordstrom in Walnut Creek last night. Police are investigating what was clearly a planned event, with the initial calls coming into the department about cars driving recklessly in the area shortly before 9:00 p.m. Nordstrom employees began calling 911 when approximately 80 people entered the store and immediately began stealing merchandise.

Two employees were assaulted and one was pepper sprayed by the suspects. Officers arrived on the scene quickly, stopping one of the cars and arresting two people, one of whom was in possession of a firearm. Another person was arrested nearby a short time later in possession of stolen Nordstrom property. The remaining participants in this criminal mob fled from the area in cars at high speeds.
