*******INVESTIGATION UPDATE*******

Date / Time Occurred: July 06, 2020 at 4:56 p.m.

Arrested: Anthony Arman Hamid, 22 year-old

Charges Filed: 664/187(a) PC, Attempted Murder with an enhancement of a firearm.
246 PC, Shooting at an occupied vehicle with an enhancement of great bodily injury.

On March 22, 2022, members of the FBI Safe Streets Task Force and Central County SWAT Team conducted an arrest warrant service in unincorporated Walnut Creek. Anthony Hamid was arrested for attempted murder related to the July 6, 2020 shooting on Homestead Ave and Ygnacio Valley Rd. in Walnut Creek.

Detectives are continuing follow-up investigation with potential witnesses, no booking photo will be shared at this time.

On March 24, 2022, the Contra Costa District Attorney's office reviewed the case and charged Hamid with attempted murder, shooting at an occupied vehicle, and two enhancements. Hamid remains in-custody awaiting trial on \$3,250,000 bail.

Location: Intersection of Homestead Ave. and Ygnacio Valley Rd.

Crime Description: Attempted Murder-PC 664/187

Suspect Description: Hispanic adult male, approximately 25 years of age, approximately 5'5",
Average build, low-cut haircut, mustache.

On July 6, 2020 at approximately 4:56 p.m., the Walnut Creek Police Department received a 911 call reporting a shooting near the intersection of Homestead Ave. and Ygnacio Valley Rd. The victim was stopped in his vehicle on Homestead Ave. in the northbound left turn lane at Ygnacio Valley Rd. While stopped, an adult Hispanic male suspect approached on foot and fired multiple shots into the victim's vehicle with a handgun. Responding officers provided first aid care to the gunshot wound victim. The victim was transported to a nearby hospital and is currently in stable condition. During the investigation, westbound Ygnacio Valley Rd. traffic was blocked near Walnut Ave., as well as northbound traffic on Homestead Ave. near Marshall Dr. for approximately two hours.

This investigation is in the early stages and information is limited at this point. Additional details will be provided as they become available. Based on preliminary information, investigators believe this is an isolated incident and do not believe there is an active threat to the community.
